Required Levels of Approval

Examples

A BOV-approved BA in Book Arts should be noted in the catalog as follows:

The university cannot accept applications or enroll students in this program until SCHEV approval has been granted.

If the title of the BA in Book Arts should change to BA in Bookbinding, the change should be noted as:

Bookbinding, BA (title change pending SCHEV approval)
