### GUIDELINES (Senior Citizen's Higher Education Act of 1974, Code of VA 23-38.54-60)

**Definition:** "Senior Citizen means any person who, before the beginning of any term, semester or quarter in which such person claims entitlement to the benefits of this chapter, (i) has reached 60 years of age, and (ii) has had a legal domicile in this Commonwealth for one year" (Code of VA 23-38.55).

#### **Eligibility:**

- A) Senior citizens may enroll to **audit** (no credit) academic courses and pay no tuition or fees, except course related fees.  
 B) Senior citizens may enroll in a course and **earn academic credit** and pay no tuition or fees, except course related fees, only if the citizens have **a taxable income not exceeding \$15,000** for Virginia income tax purposes for the year preceding the year in which enrollment is sought.

#### **Terms:**

- A) Senior citizens may enroll in no more than **three courses** in a given semester and pay no tuition.  
 B) Senior citizens shall meet the appropriate admission requirements of the institution.  
 C) Senior citizens may be denied enrollment based upon space availability in course(s).
