The purpose of this document is to assist catalog authors with the catalog editing cycle. Specifically, this document outlines the required approval steps that are needed in order to ensure that new or modifications to courses and programs make the next edition of the University Catalog.

In general, all curriculum items require a minimum of College/School Curriculum Committee (CC) and either Undergraduate Council (UGC), or Graduate Council (GC) approval. Others items (i.e. new programs) may require further levels of approval.

SCHEV Notification and Approval: Required Catalog Notation

Items submitted to SCHEV which do not receive approval by the time of catalog publication must include a notation on their respective catalog pages as follows:

Action	Title Notation	Description Notation

A BOV-approved BA in Book Arts should be noted in the catalog as follows:

Book Arts, BA (pending SCHEV approval)

The university cannot accept applications or enroll students in this program until SCHEV approval has been granted.

A BOV-approved title change for Health Policy, MS will be noted in the University Catalog as follows:

Health Policy, MS (title change pending SCHEV approval)

Note: As of catalog publication in April, the title for this program (formerly known as Health and Medical Policy, MS) has been approved by the Board of Visitors and sent to the State Council of Higher Education for Virginia.
